

TINA JONES, 1 YEAR AS A DSP WITH ONTARIO ARC

"I tell people all the time that I love my job, which is by far my FAVORITE job of any I've had. Being able to work as a team and help change the lives of our individuals and watch them grow and learn in the community is a great feeling. Working for Ontario ARC has also taught me ways to

help and better understand the needs of my 3 year old nephew, who has Down Syndrome. I can't say how truly grateful I am for that opportunity."

SHAWN INGLESBY, 18 YEARS AS A DSP WITH ONTARIO ARC

"I became a DSP right out of high school—it was only supposed to be a summer job, but I absolutely loved it. The people I support teach me to take life one day at a time, to give

yourself space to learn at your own pace, and to never let the small stuff get to you. When they go home smiling, I know I've done my job. After all these years, I'm really proud of our agency, and of all the people I've supported."



"I started as a substitute DSP after raising my kids, care-giving for my mother-in-law, and moving to this area. LIVING HER BEST LIFE SELF-DIRECTION: LACEY JACKSON

Lacey Jackson has been attending arts and crafts classes at JoAnn Fabrics in Canandaigua. When her life got busy and she was unable to attend a few classes in a row, a group of regulars from the class reached out to ask when she could attend; they said class just wasn't the same without her. The experience made it clear to Lacey, her family, and her Self-Hired Staff, Heather, how much she had really become one with her community, thanks to Self-Direction.

Lacey, who lives with her parents in Stanley, enjoyed her traditional day program and her friends there, but was ready for the next step in her life. Self-Direction was the answer so that she can fully engage with her community in all the ways that align with her dreams and her strengths.

Now Lacey's days are filled with activities of her choosing, which she carefully plans out in her budget. She began by choosing Heather, a close family friend, to be her Self-Hired Staff—together they plan day-to-day

activities, growing together by encouraging each other to push to the edges of their comfort zones.

Each week, Lacey attends a yoga class at the Canandaigua YMCA, sorts items and stocks shelves at the Canandaigua ReStore, and—as an affirmed animal whisperer—socializes cats at the Yates County Humane Society in Penn Yan. She also recently began ukulele lessons, and has already learned a number of traditional favorites such as Twinkle-Twinkle-Little-Star, Happy Birthday, and Over the Rainbow.

Lacey even plans special activities like visiting the Rosamond Gifford Zoo in Syracuse and out-of-state trips for family events. She keeps her connections with friends from her day program while attending daily occupational, speech, and physical therapy at Ontario ARC, often followed by group lunches.

Designing her life to actively take advantage of all her community has to offer is how Lacey lives this next step of her "best life," and everyone in her community is enriched by her presence.

FAQs ABOUT QUALIFIED CHARITABLE DISTRIBUTION DONATIONS

Otherwise known as Qualified Charitable Distribution, a

WHAT'S A QCD?

Distribution, a QCD is a taxfree, charitable distribution from your Traditional

IRA account that can be sent directly to a charity, including the Friends of Ontario ARC Foundation.

WHAT IS THE BENEFIT TO MAKING A QCD?

Most people, age 70 ½ and older, must take a Required Minimum Distribution (RMD) from their Traditional IRA (IRA) account each year and pay tax on 100% of the distribution. A QCD allows the donor AND the charity to avoid tax on 100% of the distribution, in most cases.

IS THERE A MAXIMUM QCD AMOUNT THAT A DONOR CAN CONSIDER EACH YEAR?

A QCD of up to \$100,000 per taxpayer is allowed in any single tax year.

HOW DO I GO ABOUT MAKING A QCD TO ONTARIO ARC?

Contact the custodian of your Traditional IRA account and have them issue a check from your account, made payable to the Friends of Ontario ARC Foundation, in an amount that you feel is appropriate. Have them mail the check directly to The Friends of Ontario ARC Foundation and make sure that the check is not made payable to you; otherwise, it will be treated as a taxable distribution.

HOW IS A QCD DIFFERENT THAN WRITING A CHECK DIRECTLY TO THE CHARITY OF MY CHOICE?

For the most part, writing a check from your personal account may only be partially deductible against your taxable income (i.e., only partially tax-free, if at all), while a QCD is typically 100% tax-free, provided that you follow all of the rules above.
